- (iv) The Total Price of Apartment or Plot includes: 1) Pro rata share in the Common Areas and 2) garage(s) closed parking(s) as provided in Agreement.
- 1.3 The Total Price is escalation free, save and except increases which the Allottee hereby agrees to pay, due to increase on account of development charges payable to the competent authority and/or any other increase in charges which may be levied or imposed by the competent authority from time to time. The Promoter undertakes and agrees that while raising a demand on the Allottee for increase in development charges, cost/charges imposed by the competent authorities, the Promoter shall enclose the said notification/order/rule/regulation to that effect along with the demand letter being issued to the Allottee, which shall only be applicable on subsequent payments.
- 1.4 The Allottee (s) shall make the payment as per the payment plan set out in Schedule C ("PaymentPlan").
- 1.5 The promoter may allow, in its sole discretion, a rebate for early payment of installment payable by the Allottee by discounting such early payments @% per annum for the period by which the respective installment has been preponed. The provision for allowing rebate and such rate of rebate shall not be subject to any revision/withdrawal, once granted to an Allottee by the Promoter.
- 1.6 It is agreed that the Promoter shall not make any additions and alternation in the sanctioned plans, layout plans and specifications and the nature of fixtures, fittings and amenities described therein in respect of the apartment, plot or building, as the case may be, without the previous written consent of the Allottee. Provided that the promoter may make such minor additions or alterations as may be required by the Allottee, or such minor changes or alterations as per the provisions of the Act.

carpet area that has been allotted to the Allottee after the construction of the Building is completed and the occupancy certificate * is granted by the competent authority, by furnishing details of the changes, if any, the carpet area. The total price payable for the carpet area shall be recalculated upon confirmation by the Promoter. If there is any reduction in the carpet area within the defined limit then Promoter shall refund the excess money paid by Allottee within forty-five days with annual interest at the rate specified in the Rules, from the date when such an excess amount was paid by the Allottee. If there is any increase in the carpet area allotted to Allottee, the Promoter shall demand that from the Allottee as per the next milestone of the payment plan. All these monetary adjustments shall be made at the same rate per square feet as agreed in Clause 1.2 of this Agreement.

- 1.8 Subject to clause 9.3 the promoter agrees and acknowledges, the Allottee shall have the right to the apartment or Plot as mentioned below:
- (i) The Allottee shall have exclusive ownership of the Apartment or Plot.
 - (ii) The Allottee shall also have undivided proportionate share in the common Areas. Since the share/interest of Allottee in the Common Areas is undivided and cannot be divided or separated the Allottee shall use the Common Areas along with other occupants, maintenance staff etc. without causing any inconvenience or hindrance to them. Further the right of the allottee to use the common area shall always be subject to the timely payment of maintenance charges and other charges as applicable. It is clarified that the promoter shall convey undivided proportionate title in the common area to the association of allottees as provided in the Act.
 - (iii) That the computation of the price of the Apartment or plot includes recovery of price of land, construction of [not only the Apartment but also] the common Areas, Internal development charges, external development charges, taxes cost of providing electrical wiring fire detection and firefighting equipment in the common areas etc. and includes cost for providing all other facilities as provided within the project.

It is agreed that the Project is an independent, self-contained Project covering the said land and is not a part of any other project or zone and shall not form a part of and/or linked/combined with any other project in its vicinity or except for the purpose of integration of infrastructure for the benefit of the Allottee. It is clarified that Project's facilities and amenities shall be available only for use and enjoyment of the Allottees of the Project.

- 1.10 It is understood by the Allottee that all other areas and i.e. areas and facilities falling outside the project namely PANCHRATNA GIRINDRA here specify the details shall not form a part of the declaration to be filed with (Please insert the name of the concerned competent authority) to be filed in accordance with the XX
- 1.11 The Promoter agrees to pay all outgoing before transferring the physical possession of the apartment to the Allottees, which it has collected from the Allottees, for the payment of outgoing (including land cost, ground rent, municipal or other local taxes, charges for water or electricity, maintenance charges, including mortgage loan and interest on mortgages or other encumbrances and such other liabilities payable to competent authorities, banks and financial institutions, which are related to the project). If the Promoter fails to pay all or any of the outgoing collected by it from the Allottees or any liability, mortgage loan and interest there on before transferring the apartment to the Allottees, the Promoter agrees to be liable, even after the transfer of the property, to pay such outgoing and penal charges, if any, to the authority or person to whom they are payable and be liable for the cost of any legal proceedings which may be taken therefor by such authority or person.

3. COMPLIANCE OF LAWS RELATING TO REMITTANCES:

- 3.1 The Allottee, if resident outside India, shall be solely responsible for complying with the necessary formalities as laid down in Foreign EXCHANGES Management Act, 1999, Reserve Bank of India Act and Rules and Regulations made thereunder or any statutory amendment (modification (s) made thereof and all other applicable (s) laws including that of payment acquisition /sale/transfer of immovable remittance properties in India etc. and provide the promoter with such permission, approvals which would enable the Promoter to fulfill its obligations under this Agreement. Any refund, transfer of security, if provided in terms of the Agreement shall be made in accordance with the provisions of Foreign Exchange Management Act, 1999 or statutory enactments or amendments thereof and the Rules and regulations of the Reserve Bank of India or any other applicable law. The Allottee understands and agrees that in the event of any failure on his/her part to comply with the applicable guidelines issued by the Reserve Bank of India, he/she shall be liable for any action under the foreign exchange management Act, 1999 or other laws as applicable as amended from time to time.
- 3.2 The Promoter accepts no responsibility in this regard. The allottee shall keep the promoter fully indemnified and harmless in this regard. Whenever there is any change in the residential status of the Allottee subsequent to the signing of this Agreement, it shall be the sole responsibility of the Allottee to intimate the same in writing to the Promoter immediately and comply with necessary formalities if any under the applicable laws. The promoter shall not be responsible towards any third-party making payment/remittances on behalf of any allottee and such third party shall not have any right in the application/allotment of the said apartment applied for herein any way and the promoter shall be issuing the payment receipts in favour of the Allottee only.

4.4 ADJUSTMENT/APPROPRIATION OF PAYMENTS:

The Allottee authorized the promoter to adjust/appropriate all payments made by him/her under any head (s) of dues against lawful outstanding, if any, in his/her name as the promoter may in its sole discretion deem fit and the allottee undertakes not to object /demand/direct the promoter to adjust his payments in anymanner.

4. TIME ISESSENCE

1.13 Time is of essence for the Promoter as well as the Allottee. The Promoter shall abide by the time schedule for completing the project and handing over the Apartment or Plot to the Allottee and the common areas to the association of the allottees after receiving the occupancy certificate or the completion certificate or both, as the case may be similarly the Allottee shall make timely payments of the installment and other dues payable by him/her and meeting the other obligation under the Agreement subject to the simultaneous completion of construction by the promoter as provided in schedule C ("PaymentPlan")

6. CONSTRUCTION OF THE PROJECT OR APARTMENT:-

The allottee has seen the specifications of the Apartment or Plot and accepted the payment plan, floor plans, layout plans [annexed along with his agreement] which has been approved by the competent authority as represented by promoter. The Promoter shall develop the project in accordance with the said layout plans, specifications. Subject to the terms in this plans and agreement, the promoter undertakes to strictly abide by such plans approved by competent authorities shall also strictly abide by bye- laws, FAR and density norms and provision prescribed bythe_[Please insert the relevant State laws] and shall not have an option to make any variation/alteration/modification/in such plans, other than in the manner provided under the Act, and breach of this term by the Promoter shall constitute a material breach of theAgreement.

7. POSSESSION OF THE APARTMENT OR PLOT

7.1 Schedule for possession of the said Apartment /Plot: The Promoter agrees and understands that timely delivery of possession of the Apartment or Plot is the essence of the Agreement. The promoter based on the approval plans specifications and assures hand over possession of the apartment or plot unless there is delay or failure due to war, flood, drought, fire, cyclone, earthquake or any other calamity caused by nature affecting the regular development of the real estate project (Force Majeure). If, however, the completion of the Project is

delayed due to the FORCE Majeure conditions then the Allottee agrees that the Promoter shall be entitled to the extension of time for delivery of possession of the APARTMENT OR Plot, provided that such force majeure conditions are of a nature which make it impossible for the contract or be implemented. The Allottee agrees and confirms that, in the event it becomes impossible for the Promoter to implement the project due to force Majeure conditions, then this allotment shall stand terminated and the Promoter shall refund to the Allottee the entire amount received by the Promoter from the allotment within 45 days from that date. After refund of the money paid by the Allottee, Allottee agrees that he shall not have any rights, claims etc. against the promoter and that the promoter shall be released and discharged from all its obligations and liabilities under this Agreement.

- 7.2 Procedure for taking possession –The Promoter upon obtaining the occupancy certificate from the competent authority shall offer in writing the possession of the apartment or plot, to the allottee in terms of this agreement to be taken within 3 (three months from the date of issue of such notice and the promoter shall give possession of the apartment or plot to the allottee. The promoter agrees and undertakes provisions to indemnify the allottee in case of failure of fulfillment of any of the formalities, documentation on part of the Promoter. The allottee agrees(s) to pay the maintenance charges as determined by the promoter/association of allottees as the case may be. The Promoter on its behalf shall offer the possession Allottee to the in writing within days of receiving the occupancy certificate of the Project.
- 7.3 Failure of Allottee to take possession of Apartment or Plot –Upon receiving a written intimation from the Promoter as per clause 7.2, the allottee shall take possession of the Apartment or plot from the Promoter by executing necessary indemnities, undertakings and such other documentation as prescribed in this Agreement, and the Promoter shall give possession of the Apartment or plot to the allottee. In case the allottee fails to take possession within the time provided in clause 7.2 such allottee shall continue to be liable to pay maintenance charges as applicable.
- 7.4 Possession by the Allottee – After obtaining the occupancy certificate and handing over physical possession of the Apartment or plot to the Allottees, it shall be the responsibility of the promoter to hand over the necessary documents and plans

including common areas to the association of the Allottees or the competent authority, as the case may be, as per the local laws.

- 7.5 Cancellation by Allottee –The Allottee shall have the right to cancel/withdraw his allotment in the project as provided in the ACT.

Provided that where the allottee propose to cancel/withdraw from the project without any fault of the promoter, the promoter herein is entitled to forfeit the booking amount paid for the allotment. The balance amount of money paid by the allottee shall be returned by the promoter to the allottee within 45 days of such cancellation.

7.6 Compensation –The Promoter shall compensate the Allottee in case of any loss caused to him due to defective title of the land, on which the project is being developed or has been developed, in the manner as provided under the Act and the claim for compensation under this section shall not be barred by limitation provided under any law for the time being in force. Except for occurrence of a Force Majeure event, if the promoter fails to complete or is unable to give possession of the Apartment or Plot (i) in accordance with the terms of this Agreement, duly completed by the dates specified herein or (ii) due to discontinuance of his business as a developer on account of suspension or revocation of the registration under the Act, or for any other reason, the Promoter shall be liable, on demand to the allottees, in case the allottee wishes to withdraw from the project without prejudice to any other remedy available to return the total amount received by him in respect of the apartment or plot, with interest at the rate specified in the Rules within 45 days including compensation in the manner as provided under the Act. Provided that where if the allottee does not intend to withdraw from the project the promoter shall pay the allottee interest at the rate specified in the rules for every month of delay, till the handing over of the possession of the Apartment or Plot.

8. Representation and warranties of the Promoter–

The Promoter hereby represents and warrants to the Allottee as follows:

- (i) The [Promoter] has absolute, clear and marketable title with respect to the said land, the requisite rights to carry out development upon the said land and absolute actual, physical and legal possession of the said land for the project.

- (ii) The Promoter has lawful rights and requisite approvals from the competent authorities to carry out development of the Project.
- (iii) There are no encumbrances upon the said land or the project.
(in case there are any encumbrances on the land, provide details of such encumbrances including any rights, title, interest and name of party in or over such land]
- (iv) There are no litigations pending before any court of law with respect to the said land, project or the apartment or plot.
- (v) All approvals, licenses and permits issued by the competent authorities with respect to the project, said land and apartment or plot are valid and subsisting and have been obtained by following due process of law. Further, the Promoter has been and shall, at all times, remain to be in compliance with all applicable laws in relation to the project, said land, Building and apartment or plot and common areas. The Promoter has the right to enter into this Agreement and has not committed or omitted to perform any act or thing, whereby the right, title and interest of the allottee created herein, may prejudicially be affected.
- (vi) The Promoter has not entered into any agreement for sale and/or development agreement or any other agreement/arrangement with any person or party with respect to the said land, including the project and the said apartment or plot which will in any manner affect the rights of allottee under this agreement.
- (vii) The promoter confirms that the promoter is not restricted in any manner whatsoever from selling the said Apartment or plot to the allottee in the manner contemplated in this Agreement.
- (viii) At the time of execution of the conveyance deed the Promoter shall handover lawful vacant, peaceful, physical possession of the Apartment or plot to the allottee and the common areas to the Association of the allottees.
- (ix) The Schedule Property is not the subject matter of any HUF and that no part hereof is owned by any minor and/or no minor has any right, title and claim over the schedule property.
- (x) The Promoter has duly paid and shall continue to pay and discharge all

- (xi) No notice from the Government or any other local body or authority or any legislative enactment, government, ordinance, order, notification (including any notice for acquisition or requisition of the said property) has been received by or served upon the promoter in respect of the said land and/or the project.

9. EVENTS OF DEFAULTS AND CONSEQUENCES:-

9.1 Subject to the Force Majeure clause, the Promoter shall be considered under a condition of Default, in the following events:

- (i) Promoter fails to provide ready to move in possession of the Apartment or plot to the allottee within the time period specified. For the purpose of this clause, ready to move in possession shall mean that the apartment shall be in a habitable condition which is complete in all respects.
- (ii) Discontinuance of the Promoter's business as developer on account of suspension or revocation of his registration under the provision of the Act or the rules or regulations made thereunder.

9.2. In case of Default by Promoter under the conditions listed above, Allottee is entitled to the following:

- (i) Stop making further payments to promoter as demanded by the Promoter. If the allottee stops making payments, the promoter shall correct the situation by completing the construction milestones and only thereafter the allottee be required to make the next payment without any penal interest.
- (ii) The allottee shall have the option of terminating the Agreement in which case the Promoter shall be liable to refund the entire money paid by the Allottee under any head whatsoever towards the purchase of the apartment, along with interest at the rate specified in the Rules forty-five days of receiving the termination notice. Provided that where an Allottee does not intend to withdraw from the project or terminate the agreement, he shall be paid, by the promoter, interest at the rate specified in the Rules, for every month of delay till the handing over of the possession of the Apartment or plot.

- 9.3 The Allottee shall be considered under a condition of Default, on the occurrence of the following events:

22. **ENTIRE AGREEMENT** –This Agreement, along with its schedules, constitutes the entire agreement between the parties with respect to the subject matter hereof and supersedes any and all understandings, any other agreements, allotment letter, correspondences, arrangements whether written or oral, if any, between the parties

It is made clear and so agreed by the allottee that exercise of discretion by the Promoter in the case of one Allottee shall not be construed to be a precedent and/or binding on the promoter to exercise such discretion in the case of other allottees.

25.2 Failure on the part of the promoter to enforce at any time or for any period of time the provision hereof shall not be construed to be a waiver of any provision or of the right thereafter to enforce each and every provision.

26. **SEVERABILITY**

If any provision of this Agreement shall be determined to be void or unenforceable under the Act or the Rules and Regulations made hereunder or under other applicable laws, such provision of the Agreement shall be deemed amended or deleted in so far as reasonably inconsistent with the purpose of this Agreement and to the extent necessary to conform to Act or the Rules and Regulations made thereunder or the applicable law, as the case may be, and the remaining provision of this Agreement shall remain valid and enforceable as applicable at the time of execution of this Agreement.

27. **METHOD OF CALCULATION OF PROPORTIONATE SHARE WHEREVER REFERRED TO IN THE AGREEMENT–**

29. PLACE OF EXECUTION—

The execution of this Agreement shall be complete only upon its execution by the Promoter through its authorized signatory at the Promoter's Office, or at some other place, which may be mutually agreed between the Promoter and the allottee, in after the agreement is duly executed by the allottee and Promoter or simultaneously with the execution the said Agreement shall be registered at the office of the Sub-Registrar. Hence this Agreement shall be deemed to have been executed at.
