- 1.3 The total price is escalation-free, save and except increases which the Allottee hereby agrees to pay due to increase on account of development charges payable to the competent authority and/or any other increase in charges which may be levied or imposed by the competent authority from time to time. 

- 1.6 It is agreed that the Bijay Shree and Sapna construction pvt. ltd. shall not make any additions and alterations in the sanctioned plans, layout plans and specifications and the nature of fixtures, fitting and amenities described therein in respect of the apartment, plot or building, as the case may be without the previous written consent of the Allottee. Provided that the Bijay Shree and Sapna construction pvt. ltd. may make such minor additions or alterations as may be required by the Allottee or such minor changes or alterations as per the provisions of the Act.
- 1.7 [Applicable in case of an apartment] The Bijay Shree and Sapna construction pvt. ltd. shall confirm the final carpet area that has been allotted to the Allottee after the construction of the building is complete and the occupancy certificate* is granted by the component authority by furnishing details of the changes if any in the carpet area. The total price payable for the carpet area shall be recalculated upon confirmation by the Bijay Shree and Sapna construction pvt. ltd.. If there is any reduction in the carpet area within the defined limit then Bijay Shree and Sapna construction pvt. ltd. shall refund the excess money paid by Allottee within forty-five day with annual interest at the rate specified in the rules from the date when such an excess amount was paid by the Allottee. If there is any increase in the carpet area allotted to Allottee, the Bijay Shree and Sapna construction pvt. ltd. shall demand that from the Allottee as per the next milestone of the payment plan. All these monetary adjustments shall be made at the same rate per square feet as agrees in clause 1.2 of this agreement.
- 1.8 Subject to clause 9.3 the Bijay Shree and Sapna construction pvt. ltd. agrees and acknowledges, the Allottee shall have the right to the apartment or plot as mentioned below:
- (i) The Allottee shall have exclusive ownership of the apartment or plot;
 - (ii) The Allottee shall also have undivided proportionate share in the common areas, since the share/interest of Allottee in the common areas is in divided and cannot be divided or separated, the Allottee shall use the common areas along with other occupants, maintenance staff etc. Without causing any inconvenience or hindrance to them. Further the right of the Allottee to the common areas shall always be subject to the timely payment of maintenance charges and other charges as applicable. It is clarified that the Bijay Shree and Sapna construction pvt. ltd. shall convey undivided proportionate title in the common areas to the association of allottees as provided in the Act;
 - (iii) That the computation of the price of the apartment or plot includes recovery of price of land, construction of [not only the apartment but also] the common areas, internal development charges, external development charges, taxes, cost of providing electric wiring, fire detection and fire-fighting equipment in the common areas etc. and includes cost for providing all other facilities as provided within the project.

It is agreed that the project is an independent, self-contained project covering the said land and is not a part of any other project or zone and shall not form a part of and/or linked/combined with any other project in its vicinity or except for the otherwise purpose of integration of infrastructure for the benefit of the Allottee. It is clarified that project's facilities and amenities shall be available only for use and enjoyment of the allottees of the project.
- 1.10 It is understood by the Allottee that all other areas and i.e. areas and facilities falling outside the project namely (XX)- here specify the details shall not form a part of the declaration to be filed with _____ [Please insert the name of the concerned component authority] to be filed in accordance with the XX _____ [XX Insert the name of the state relevant Act, if any].
- 1.11 The Bijay Shree and Sapna construction pvt. ltd. agrees to pay all outgoing before transferring the physical possession of the apartment to the allottees, which it has collected from the allottees for the payment of outgoing (including land cost, ground rent, municipal or other local taxes, charges for water or electricity , maintenance charges, including mortgage loan and interest on mortgages or other encumbrance and such other liabilities payable to competent authorities, banks and financial institutions, which are related to the project). 
3. COMPLIANCE OF LAWS RELATING TO REMITTANCES:-

- 3.1 The Allottee if resident outside India, shall be solely responsible for complying with the necessary formalities as laid down in Foreign Exchange Management Act,1999, Reserve Bank of India Act and rules and regulations made thereunder or any statutory amendment (modification(s) made thereof and all other applicable(s) laws including that of payment acquisition/sale/transfer of immovable remittance properties in India etc. and provide the Bijay Shree and Sapna construction pvt. ltd. with such permission, approvals which would enable the Bijay Shree and Sapna construction pvt. ltd. to fulfil its obligations under this agreement. Any refund, transfer of security, if provided in terms of the agreement shall be made in accordance with the provisions of Foreign Exchange Management Act, 1999 or statutory enactments or amendments thereof and the rules and regulations of the Reserve Bank of India or any other applicable law. The Allottee understands and agrees that in the event of any failure on his/her part to comply with the applicable guidelines issued by the Reserve Bank of India, he/she shall be liable for any action under the Foreign Exchange Management Act, 1999 or other laws as applicable, as amended from time to time.
- 3.2 The Bijay Shree and Sapna construction pvt. ltd. accepts no responsibility in this regard. The Allottee shall keep the Bijay Shree and Sapna construction pvt. ltd. fully indemnified and harmless in this regard. Whenever there is any change in the residential status of the Allottee subsequent to the signing of this agreement it shall be the sole responsibility of the Allottee to intimate the same in writing to the Bijay Shree and Sapna construction pvt. ltd. immediately and comply with necessary formalities if any under the applicable laws. The Bijay Shree and Sapna construction pvt. ltd. shall not be responsible towards any third party making payment/remittances on behalf of any Allottee and such third party shall not have any right in the application/allotment of the said apartment applied for herein in any way and the Bijay Shree and Sapna construction pvt. ltd. shall be issuing the payment receipts in favour of the Allottee only.


4. BADJUSTMENT/APPROPRIATION OF PAYMENTS:-

5. TIME IS ESSENCE:-

Time is of essence for the Bijay Shree and Sapna construction pvt. ltd. as well as the Allottee. The Bijay Shree and Sapna construction pvt. ltd. shall abide by the time schedule for completing the project and handing over the apartment or plot to the Allottee and the common areas to the association of the allottees after receiving the occupancy certificate* or the completion certificate or both, as the case may be. Similarly the Allottee shall make timely payments of the instalment and other dues payable by him/her and meeting the order obligations under the agreement subject to the simultaneous completion of construction by the Bijay Shree and Sapna construction pvt. ltd. as provided in **Schedule C ("Payment Plan")**.

6. CONSTRUCTION OF THE PROJECT OR APARTMENT:-

The Allottee has seen the specifications of the apartment or plot and accepted the payment plan, floor plans, layout plans [annexed along with this agreement] which has been approved by the competent authority, as represented by Bijay Shree and Sapna construction pvt. ltd.. The Bijay Shree and Sapna construction pvt. ltd. shall develop the project in accordance with the said layout plans, floor plans and specifications. 
7. POSSESSION OF THE APARTMENT OR PLOT:-

7.1 **[Schedule for possession of the said apartment/plot]**:- The Bijay Shree and Sapna construction pvt. ltd. agrees and understands that timely delivery of possession of the apartment or plot is the essence of the agreement. The Bijay Shree and Sapna construction pvt. ltd. based on the approved plans specifications, assures and assures hand over possession of the apartment or plot to on _____ . Unless there is delay or failure due to war, flood, drought, fire, cyclone, earthquake or any other calamity caused by nature affecting the regular development of the real estate project ("**Force Majeure**"). If however the completion of the product is delayed due to the force majeure conditions then the Allottee agrees that the Bijay Shree and Sapna construction pvt. ltd. shall be entitled to the extension of time for delivery of possession of the apartment or plot, provided that such force majeure conditions are not of n nature which make it impossible for the contract to be implemented. The Allottee agrees and confirms that, in the event it becomes impossible for the Bijay Shree and Sapna construction pvt. ltd. to implement the project due to force majeure conditions, then

this allotment shall stand terminated and the Bijay Shree and Sapna construction pvt. ltd. shall refund to the Allottee the entire amount received by the Bijay Shree and Sapna construction pvt. ltd. from the allotment within 45 days from that date. After refund of the money paid by the Allottee, Allottee agrees that he shall not have any rights, claims etc. against the Bijay Shree and Sapna construction pvt. ltd. and that the Bijay Shree and Sapna construction pvt. ltd. shall be released and discharged from all its obligations and liabilities under this agreement.

- 7.2 **Procedure for taking possession:-** The Bijay Shree and Sapna construction pvt. ltd. upon obtaining the occupancy certificate* from the competent authority shall offer in writing the possession of the apartment or plot to the Allottee in terms of this agreement to be taken within 3 (three) months from the date of issue of such notice and the Bijay Shree and Sapna construction pvt. ltd. shall give possession of the apartment or plot to the Allottee. The Bijay Shree and Sapna construction pvt. ltd. agrees and undertakes provisions to indemnify the Allottee in case of failure of fulfilment of any of the formalities, documentation on part of the Bijay Shree and Sapna construction pvt. ltd.. The Allottee agree(s) to pay the maintenance charges as determined by the Bijay Shree and Sapna construction pvt. ltd./association of allottees as the case may be the Bijay Shree and Sapna construction pvt. ltd. on its behalf shall offer the possession to the Allottee in writing within days of receiving the occupancy certificate* of the project.
- 7.3 **Failure of Allottee to take possession of apartment or plot:-** Upon receiving a written intimation from the Bijay Shree and Sapna construction pvt. ltd. as per clause 7.2, the Allottee shall take possession of the apartment or plot from the Bijay Shree and Sapna construction pvt. ltd. by executing necessary indemnities, undertaking and such other documentation as prescribed in this agreement and the Bijay Shree and Sapna construction pvt. ltd. shall give possession of the apartment or plot to the Allottee. In case the Allottee fails to be liable to pay maintenance charges as applicable.
- 7.4 **Possession by the Allottee:-** After obtaining the occupancy certificate* and handing over physical possession of the apartment or plot to the allottees it shall be the responsibility of the Bijay Shree and Sapna construction pvt. ltd. to hand over the necessary documents and plans including common areas to the association of the Allottee or the competent authority as the case may be as per the local laws.
- 7.5 **Cancellation by the Allottee:-** The Allottee shall have the right to cancel/withdraw his allotment in the project as provided in the Act:

Provided that where the Allottee proposes to cancel/withdraw from the project without any fault of the Bijay Shree and Sapna construction pvt. ltd., the Bijay Shree and Sapna construction pvt. ltd. herein is entitled to forfeit the booking amount paid for the allotment. - 7.6 **Compensation:-** The Bijay Shree and Sapna construction pvt. ltd. shall compensate the Allottee in case of any loss caused to him due to defective title of the land, on which the project is being developed or has been developed in the manner as provided under the Act and the claim for compensation under this section shall not be barred by limitation provided under any law for the time being in force.

Except for occurrence of a force majeure event if the Bijay Shree and Sapna construction pvt. ltd. fails to complete or is unable to give possession of the apartment or plot (i) in accordance with the terms of this agreement duly completed by the date specified herein; or (ii) due to discontinuance of his business as a developer on account of suspension or revocation of the registration under the Act; or for any other reason; the Bijay Shree and Sapna construction pvt. ltd. shall be liable on demand to the allottees in case the Allottee wishes to withdraw from the project without prejudice to any other remedy available to return the total amount received by him in respect of the apartment or plot with interest at the rate specified in the rules within 45 days including compensation in the manner as provided under the Act. Provided that where if the Allottee does not intend to withdraw from the project the Bijay Shree and Sapna construction pvt. ltd. shall pay the Allottee interest at the rate specified in the rules for every month of delay, till the handing over of the possession of the apartment or plot.






Allottee and refund the amount money paid to him by the Allottee by deducting the booking amount and the interest liabilities and this agreement shall thereupon stand terminated.

- 10. 
